There came on for consideration at a duly constituted meeting of the Mayor and Members of the City Council of the City of Hattiesburg, Mississippi, held on the 6th day of November, 2018, the following Resolution:

RESOLUTION 2018-172

INDEXING INSTRUCTIONS: 701 EuFala Ave. HATTIESBURG, MS 39401 and better described as Lot Eight (8) in Block Three (3) of the H. I. Ferguson Subdivision of Block Ten (10) of the James E. Arledge Survey or Addition to the City of Hattiesburg, Mississippi as per map or plat thereof on file in the Office of the Chancery Clerk of Forrest County, Mississippi; together with all improvements and appurtenances there unto belonging.

WHEREAS, Section 21-19-11 of the Mississippi Code of 1972, Annotated, authorizes the governing authorities of municipalities to adjudicate the actual cost to the City of Hattiesburg for cleaning properties that have been determined to be in such a state of uncleanliness as to be a Menace to the public health and safety of the community, and that the owner has failed, after appropriate notice, to clean said property; and

WHEREAS, the following property has been cleaned by the City of Hattiesburg (Public Works) on or about August 15, 2018 on behalf of the City.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the City of Hattiesburg, Mississippi:

Section 1. That the City Council of the City of Hattiesburg does hereby adjudicate and direct the placement as an assessment the cleanup cost, not to exceed the value of the property per State Law, against the following described property:
