**RESOLUTION 2018-173**

**INDEXING INSTRUCTIONS: 315 Miller ST. HATTIESBURG, MS 39401** and better described as: Lot 9, Block 5, C.J. Miller Survey, and Forrest County, Mississippi, as per the official map or plat thereof on file in the office of the Chancery Clerk of Forrest County, Mississippi

**WHEREAS**, Section 21-19-11 of the Mississippi Code of 1972, Annotated, authorizes the governing authorities of municipalities to adjudicate the actual cost to the City of Hattiesburg for cleaning properties that have been determined to be in such a state of uncleanness as to be a Menace to the public health and safety of the community, and that the owner has failed, after appropriate notice, to clean said property; and
