RESOLUTION 2019-59

INDEXING INSTRUCTIONS: 3500 Peach St. better described as: Lot 8 less the West 18 feet, Block 2 of the Sunny acres subdivision, Forrest County, MS

WHEREAS, Section 21-19-11 of the Mississippi Code of 1972, Annotated, authorizes the governing authorities of municipalities to adjudicate the actual cost to the City of Hattiesburg for cleaning properties that have been determined to be in such a state of uncleanness as to be a Menace to the public health and safety of the community, and that the owner has failed, after appropriate notice, to clean said property; and

WHEREAS, the following property has been cleaned by MSP on behalf of the City.
