

There came on for consideration at a duly constituted meeting of the Mayor and Members of the City Council of the City of Hattiesburg, Mississippi, held on the 19<sup>th</sup> day of February, 2019, the following resolution:

**RESOLUTION 2019-69**

**A RESOLUTION OF THE CITY OF HATTIESBURG AMENDING THE COMPREHENSIVE PLAN 2008-2028, TO INCLUDE THE TWIN FORKS RISING MASTER PLAN, PHASE III, FOR THE TWIN FORKS AREA (WARD 2) AS AN APPENDIX.**

WHEREAS, the City of Hattiesburg has adopted the Comprehensive Plan for the City of Hattiesburg dated December 16, 2008, Resolution # 2008-192, and

WHEREAS, the purpose of the 2008 Comprehensive Plan is to identify the long-range goals and policies that should be used to guide public and private decision-making related to Hattiesburg's future growth and community development, and

WHEREAS, the Twin Forks Rising ("TFR") Phase III will guide the City of Hattiesburg, with the help of the Twin Forks Rising Community Development Corporation, in defining programs, setting priorities, allocating finances and assessing milestones, and

WHEREAS, the TFR Phase III final report is to provide the City Council of the City of Hattiesburg a clear roadmap of how the first phase of the Master Development for Ward 2, redubbed Twin Forks Rising, of Hattiesburg will be implemented, and

WHEREAS, the Planning Commission voted on February 6, 2019, to approve the petition filed by The City of Hattiesburg to consider and adopt the Twin Forks Rising Master Plan, Phase III for the Twin Forks area (Ward 2). This plan represents an amendment to "Comprehensive Plan 2008-2028" of the City of Hattiesburg, Mississippi.

NOW THEREFORE BE IT RESOLVED that the City's Comprehensive Plan 2008-2028, be amended to include the Twin Forks Rising Master Plan, Phase III for the Twin Forks area (Ward 2) as an appendix.

The foregoing resolution having been reduced to writing was introduced by Council Member Delgado, seconded by Council Member Brown and was adopted by the following vote, to wit:
